Purpose

The Delta Independent Science Board (Delta ISB) will meet regarding its current reviews and efforts. This meeting will include updates on the recruitment of the next Delta lead scientist (see <u>iob announcement</u>), organizing a workshop to inform the Delta Plan Interagency Implementation Committee's (DPIIC's) science needs assessment, the status of current Delta ISB reviews, and planning future reviews on the adequacy of science in support of adaptive management in the Delta. As a follow-up to actions taken at its September 12, 2019, meeting, the Delta ISB will discuss the status of submitting a letter to the Delta Stewardship Council on its review of the draft Delta Plan Ecosystem Amendment Performance Measures (pursuant to Water Code Section 85308(a)), and the status of submitting the final report to the Interagency Ecological Program (IEP) on the Delta ISB's review of IEP's ability to provide science supporting management of the Delta.
