Based on the discussion, the Delta ISB may take action on next steps for finalizing each prospectus, which may include circulating the prospectus to various mailing lists for public comments. In addition, the Delta ISB will discuss the election of a new Chair-elect and may take action to elect a new Chair-elect from its existing membership.

According to the draft prospectus, the purpose of this review is to support ongoing and future subsidence management efforts by summarizing, examining, and assessing the existing or planned programs, barriers and opportunities, state of scientific understanding, and the scientific gaps and deficiencies of interconnected areas of subsidence. Based on the discussion, the Delta ISB may take action on next steps for finalizing the prospectus, which may include circulating the prospectus for public comments.

10. Discussion: Food-webs Review (**Action Item**)

The Delta ISB will discuss its draft prospectus for its review of food-webs. According to the draft prospectus, the purpose of this review is to assess the importance of food web interactions in the Delta, and to identify where improved understanding and tools (e.g., food web models) could substantially improve predictions of species' responses to environmental drivers and management actions. Based on the discussion, the Delta ISB may take action on next steps for finalizing the prospectus, which may include circulating the prospectus for public comments.
