#### Bay-Delta Conservation Plan/California WaterFix

The Bay Delta Conservation Plan (BDCP) was a project that was considering large-scale improvements in water conveyance (later California WaterFix) and large-scale ecosystem restoration in the Bay-Delta. Under its legislative mandate, the Delta ISB was charged with reviewing the environmental impact report/statement (EIR/S) for BDCP and providing comments to both the California Department of Fish and Wildlife (CDFW) and the Delta Stewardship Council on the EIR/S. The Delta ISB's comments were meant to help the Delta Stewardship Council decide whether to incorporate BDCP into the Delta Plan, and CDFW decide whether to approve BDCP as a Natural Community Conservation Plan. However, BDCP/California WaterFix was withdrawn by project proponents and never implemented. Even so, the final

reviews that were submitted to CDFW and the Delta Stewardship Council, along with other comment letters, are in the table below.
