# 7. SUSTAINABLE GROUNDWATER MANAGEMENT AND THE DELTA PLAN (INFORMATION ITEM)

Executive Officer Jessica Pearson highlighted the importance of the Sustainable Groundwater Management Act (SGMA) and its relation to the Delta Plan. Jeff Henderson, deputy executive officer for planning and performance, introduced the panel: Molly Williams, sea grant fellow; Taryn Ravazzini, deputy director of statewide groundwater management, Department of Water Resources (DWR); and Natalie Stork, chief of the groundwater management program, State Water Resources Control Board (Water Board).

Ravazzini provided details on DWR's SGMA milestones, its application to multiple groundwater basins, and DWR's coordination with county Groundwater Sustainability Plans (GSPs). Stork provided details on the Water Board's role as an intervening and regulating party for SGMA. Williams provided details on GSPs that impact the Delta and stressed the importance of managing critically over-drafted basins.

Councilmembers and the panel discussed county coordination and responsibilities, relationships with local communities, and concerns about reduced reliance on the Delta.

- Annie Merritt, CivicSpark climate fellow for the Council's Planning and Performance Division, presented her work supporting Delta Adapts and developing a synthesis from Delta Adapts' vulnerability assessment for the City of West Sacramento.
- Byron Riggins, California Sea Grant state fellow for the Delta Science
   Program's Collaborative Science and Peer Review Unit, presented several
   projects, including support for the development of the Science Action
   Agenda, establishing and coordinating the Council's Delta Diversity Team,
   creating a science communication video for National Estuaries Week, and a
   personal project looking at potential implications for the Delta of
   groundwater sustainability plans for non-critically over-drafted basins under
   SGMA.
- Cheryl Patel, California Sea Grant state fellow for the Delta Science Program's Science-Based Adaptive Management Unit, presented work organizing the upcoming public symposium on zooplankton ecology, supporting the Science Needs Assessment Workshop and discussion series, supporting the Delta Independent Science Board's Monitoring Enterprise Review, and developing a synthesis effort related to habitat restoration projects.
- Molly Williams, California Sea Grant state fellow for the Council's Planning and Performance Division, presented her contributions to Delta Adapts, including analyzing seasonal shifts in storm surge events, water-supplysystem sensitivity, potential flood risk zones, and visualization of social vulnerability data.
