MEETING SUMMARY

1. WELCOME AND INTRODUCTIONS

Chair Virginia Madueño called the meeting to order at 9:00 AM on February 23, 2023.

2. ROLL CALL - ESTABLISH A QUORUM (WATER CODE §85210.5)

Roll call was taken, and a quorum was established. The following councilmembers were present: Burgis, Damrell, Lee, Smith, Zingale, and Madueño.

5. COUNCIL CONSIDERATION AND POSSIBLE ADOPTION OF PROPOSED RULEMAKING FOR SECTION 5001 (DEFINITIONS) AND SECTION 5012 (DELTA LEVEES INVESTMENT STRATEGY) (DELTA PLAN POLICY RR P1) OF TITLE 23 OF THE CALIFORNIA CODE OF REGULATIONS (GOVERNMENT CODE §11346.8) (RESOLUTION 2023-01) (ACTION ITEM)

*Note: the presentation for this agenda item was restarted to accommodate for technical difficulties with the Zoom link on the meeting notice. Once resolved, the presentation for the agenda item resumed from the beginning for both in-person and virtual attendees.

The Council held a public hearing for the public to present statements, contentions, and arguments, either orally and/or in writing or both regarding the proposed rulemaking action. Chair Madueño presided as the hearing officer and opened the hearing at approximately 10:00 am. The hearing was recorded by a certified court reporter.

Council staff presented the proposed rulemaking for the Delta Levees Investment Strategy (DLIS), including revisions made after the November 17, 2022, public hearing and receipt of public comments, and recommended that Council adopt the proposed regulatory amendments for Section 5001 (Definitions) and Section 5012 (Prioritization of State Investments in Delta Levees and Risk Reduction (Delta Plan Policy RR P1)) of Title 23 of the California Code of Regulations (Office of Administrative Law File No. Z2022-0816-07) for the implementation of DLIS, as revised after November 17, 2022, public hearing and receipt of public comments (Revised Proposed DLIS Rulemaking).

9. CHAIR'S REPORT (INFORMATION ITEM)

Chair Madueño provided comments on the Tribal nation Conference and the Delta Plan Interagency Implementation Committee (DPIIC) Restoration Forum. She echoed the importance of communication with tribal entities and asked that Brandon Chapin, the Council's Tribal Liaison, report back on the conference.

Chair Madueño highlighted that only one landowner was present at the DPIIC Forum, which she took as a signal to improve the Council engagement of landowner groups.

Following those reports, Chair Madueño congratulated Julie Lee on her confirmation.

Chair Madueño stated that she continues to meet with California legislators and County Supervisors and emphasized that Legislative Director Brandon Chapin was able to organize a legislative briefing last week, attended by Executive Officer Jessica Pearson, Lead Scientist Dr. Laurel Larson, and Deputy Executive Officer for Science Henry DeBey.

10. EXECUTIVE OFFICER'S REPORT (INFORMATION ITEM)

Executive Officer Jessica Pearson congratulated Councilmember Lee on her confirmation.

Pearson reported that the Governor signed an Executive Order on February 13 to address the state's water supplies. The Order authorized the State Water Resources Control Board to consider modifying the requirements for storage releases for the Central Valley and State Water Projects, modifications that were granted on February 22, 2023, by the Water Board. The order also charges state agencies to submit recommendations for how to address ongoing emergency drought response.

Pearson affirmed that Council staff will monitor the actions taken in response to this Executive Order, and will provide future updates as they occur.

Pearson shared that on February 13, the Department of Water Resources submitted a certification for the McCormack Williamson Tract Levee Modification and Habitat Restoration Project – Phase B. This project was initially submitted to the Council as a certification in 2018, but the Department issued a Supplemental EIR due to some project changes to Phase B. The project seeks to degrade existing levees surrounding McCormack Williamson Tract at three locations, allowing regular freshwater and tidal inundation to restore habitat within the interior and significant flood protection downstream during large flood events. The project is currently in its 30-day review period, which expires on March 15, 2023.

b. Legislative Update (ACTION ITEM)

There was no legislative update.

c. Council 2023 Work Plan

Pearson introduced the panel for the Council's 2023 Work Plan after speaking on the Council's long-term and near-term needs, projects, and trends in pursuit of the agency's mission.

Pearson reported that the Delta Adapts Adaptation Strategy and Environmental Justice Issue Paper will be completed this year and that projects, such as the Five-Year Review of the Delta Plan, or other initiatives, such as the 2023 Proposal Solicitation Notice, will begin in earnest.

The panel included: Ryan Stanbra, chief deputy executive officer; Jeff Henderson, deputy executive officer for Planning and Performance; Henry DeBey, deputy executive officer for Delta Science Program; and Amanda Bohl, special assistant for Planning and Science.

The Panel spoke on three overarching objectives:

- Objective 1: Implement the Delta Plan
- Objective 2: Advance One Delta, One Science
- Objective 3: Enhance Outreach and Engagement

Councilmember Lee requested that the Council get regular updates on the Justice, Equity, Diversity, and Inclusion program.

Councilmember Burgis requested that the Dutch Slough meeting be moved to another date, so she could attend.

Chair Madueño, Henry DeBey, and Dr. Larsen discussed extreme weather priority and how to address the phenomena programmatically and scientifically.

Chair Madueño closed the panel by highlighting the idea of progression and the need to facilitate areas to grow the landscape for incorporating equity in the Council's work.

Lead Scientist Dr. Laurel Larsen featured the article:

Environmental DNA Methods for Ecological Monitoring and Biodiversity Assessment in Estuaries Raman P. Nagarajan, Mallory Bedwell, Ann E. Holmes, Thiago Sanches, Shawn Acuña, Melinda Baerwald, Matthew A. Barnes, Scott Blankenship, Richard E. Connon, Kristy Deiner, Daphne Gille, Caren S. Goldberg, Margaret E. Hunter, Christopher L. Jerde, Gordon Luikart, Rachel S. Meyer, Alison Watts, and Andrea Schreier. Estuaries and Coasts (2022) https://doi.org/10.1007/s12237-022-01080-y.

The article seeks to summarize the state of the science for applying eDNA techniques in estuaries. In addition, it explores how these techniques could address specific management questions in the San Francisco Estuary.

Dr. Larsen reported on the CNRA science day, on February 13, explaining that the Delta Science Program participated as a partner in the first inaugural California Council on Science and Technology (CCST).

Dr. Larsen noted that the Delta Science Program hosting the Integrated Modeling Framework Workshop, on February 28 and March 1—to include focused discussion on topics like cyberinfrastructure, human resources, and best practices for implementing modeling and sharing modeling results.

Dr. Larson highlighted the Interagency Ecological Program (IEP) 2023 Workshop. The workshop will be held in the California Natural Resources Headquarters in downtown Sacramento. The workshop will be a free hybrid (in-person and virtual) event.

12. SOCIAL SCIENCE INTEGRATION TEAM PRESENTATION (INFORMATION ITEM)

Council staff on the Social Science Integration Team presented the accomplishments in 2022 and the ongoing efforts that aim to increase interdisciplinary science.

The presentation emphasized how social sciences integration into environmental science and management in the Sacramento-San Joaquin Delta (Delta) can contribute to a better understanding of the people who live, work, and recreate in and around the estuary, how the region impacts their health and well-being, and how their behaviors influence environmental issues, in furtherance of the coequal goals.

The panel included: Dr. Jess Rudnick, social science extension specialist; Cory Copeland, senior environmental scientist; Dr. Chelsea Batavia, senior environmental scientist; and Beck Barger, public participation manager.

Councilmember Burgis emphasized the importance of the subject matter, and the need to build community trust and measure it in the future.

Chair Madueño echoed Councilmember Burgis' comments and expanded on the need for community trust, and encouraged advertising the survey broadly through a variety of local media outlets
