2. Re-imagining the Delta Monitoring Enterprise

Monitoring governance and reform for the Sacramento-San Joaquin Delta is being discussed in many venues, with multiple DPIIC agencies actively participating in these discussions. As reviews and changes are being considered, what does DPIIC—as a collaborative entity—want out of these processes? What structure and process will best serve the needs of the Delta and collective efforts to achieve the coequal goals of water supply reliability and ecosystem health? This panel will explore current review efforts and discuss how to move forward.

3. Furthering One Delta, One Science

a. 2022-2026 Science Action Agenda

The Science Action Agenda (SAA) is a collaboratively developed, four-to-five-year science agenda for the Sacramento-San Joaquin Delta that prioritizes and aligns science actions to inform management decisions, identifies major gaps in knowledge, promotes collaborative science, and builds science infrastructure. DPIIC members will hear a presentation from Henry DeBey and Rachael Klopfenstein from the Delta Stewardship Council regarding the SAA and be asked to endorse the 2022-2026 SAA.

b. Delta Crosscut Budget Report

DPIIC and state, federal, and local water agencies have worked collaboratively for the past three years to submit and analyze Delta science funding data. Mario Manzo, assistant Bay-Delta office manager, U.S. Bureau of Reclamation, will present the 2020-2021 Delta Crosscut Budget Report.

c. Long-term Drought and Salinity Management Needs

Delta Lead Scientist Dr. Laurel Larsen will update the Committee on efforts to address long-term drought and salinity management needs, including the salinity management workshop series and a proposal to the University of California Office of the President for a center focused on addressing long-term drought and salinity management needs using a participatory, scenario-based approach.

Committee Action: Committee members will be asked to continue to commit staff to participate in the collaborative process kicked off by the salinity management workshop series.
