Purpose

The Delta ISB will meet to discuss its reviews and activities, which will help inform the Delta ISB's 2024 annual work plan. This will include a discussion on Delta ISB's draft comment letter on the draft Staff Report released by the State Water Resources Control Board in support of Sacramento/Delta updates to the Bay-Delta Water Quality Control Plan. Based on the discussion, the Delta ISB may take action on next steps for submitting the comment letter.

In addition, the Delta ISB will discuss the final Environmental Impact Report released by the California Department of Water Resources for the Delta Conveyance Project, and potentially drafting a memo on how well Delta ISB comments on the draft Environmental Impact Report were addressed. Based on the discussion, the Delta ISB may take action on next steps for reviewing the Final Environmental Impact Report.

- 2. Delta ISB Chair Report and Business Matters
- 3. <u>Presentation:</u> Review and Recommendations of Bifenthrin Mixtures in the Sacramento San Joaquin Delta for a Changing Future
 - Eduardo Martinez, California Sea Grant State Fellow with the Council's Delta Science Program, will present results from his review to address gaps in bifenthrin research and management, along with recommendations to address those gaps. Bifenthrin, a synthetic pyrethroid heavily used in urban and agricultural areas for pest management, is frequently detected and is known to affect sensitive aquatic species in the Delta.
- 4. Discussion: Sacramento/Delta Update to the Bay-Delta Water Quality Control Plan (Next Steps)
 - The State Water Resources Control Board is currently considering updates to the Bay-Delta Water Quality Control Plan focused on the Sacramento River and its tributaries, Delta eastside tributaries (including the Calaveras, Cosumnes, and Mokelumne Rivers), interior Delta flows, and Delta outflows, including consideration of proposed voluntary agreements. On September 28, 2023, the State Water Resources Control Board released a draft Staff Report in support of Sacramento/Delta updates to the Bay-Delta Water Quality Control Plan for public review and comment, which are due on January 19, 2024. The Delta ISB will discuss the draft Staff Report and its draft comment letter to the State Water Resources Control Board. Based on the discussion, the Delta ISB may take action on next steps for submitting the comment letter.
- Discussion: Delta Conveyance Project Final Environmental Impact Report Review

The California Department of Water Resources released the Final Environmental Impact Report for the Delta Conveyance Project on December 8, 2023, and certified the report on December 21, 2023. The Delta ISB will discuss the final Environmental Impact Report, and potentially drafting a memo on how well its comments on the draft Environmental Impact Report were addressed. Based on the discussion, the Delta ISB may take action on next steps for reviewing the Final Environmental Impact Report.

6. Discussion: Decision-making Under Deep Uncertainty Review

The Delta ISB will discuss progress made on its decision-making under deep uncertainty review (see prospectus). The review will build an understanding of the scientific tools and concepts that can increase the capacity to anticipate and adapt to growing uncertainty of future conditions in the Bay-Delta system.

7. Discussion: Subsidence Review

The Delta ISB will discuss progress made on its subsidence review (<u>see prospectus</u>). This review will synthesize and evaluate the state of science related to subsidence management in order to provide recommendations to inform and guide ongoing and future subsidence management.

8. Discussion: Food-webs Review

The Delta ISB will discuss progress made on its food-webs review (<u>see prospectus</u>). The review will assess the importance of food-web interactions in the Delta, and identify where improved understanding and tools (e.g., food-web models) might substantially improve predictions of an individual species' response to environmental drivers and management actions.
