

Inadequate aquatic life protection under CWA programs

Long term and recent population declines in pelagic fish and salmonids



Abundant and persistent water quality impairments

EPA SF Bay Delta Estuary Action Plan

1. Strengthen estuarine habitat protection standards
2. Advance regional water quality monitoring and assessment
3. Accelerate water quality restoration through Total Maximum Daily Loads
4. Strengthen selenium water quality criteria
5. Improve pesticide pollution prevention
6. Restore aquatic habitats while managing methylmercury
7. Support development of the Bay Delta Conservation Plan

Strengthen Estuarine Habitat Water Quality Standards

- Delta outflow
- San Joaquin and Sacramento Inflows
- Old and Middle River flows
- Floodplain flows




Figure 42 Spatial distribution of the percentile level of Indicator days for July for the period 2000–2009





Figure 67 Species Richness - July
