MEETING SUMMARY

1. WELCOME AND INTRODUCTIONS

Chair Julie Lee called the meeting to order at 9:34 AM on December 19, 2024, at the California Natural Resources Building at 715 P Street, Room 221, Sacramento, CA 95814.

2. ROLL CALL – ESTABLISH A QUORUM (WATER CODE §85210.5)

Roll call was taken, and a quorum was established. The following councilmembers were present: Burgis, Damrell, Hueso, Mehranian, Zingale and Lee.

Vice Chair Miller joined the meeting during agenda item 3.

3. PUBLIC HEARING ON APPEALS OF THE DEPARTMENT OF WATER RESOURCES CERTIFICATION OF CONSISTENCY NUMBER C20242 FOR THE 2024-2026 PROPOSED GEOTECHNICAL ACTIVITIES AND POSSIBLE CONSIDERATION AND ADOPTION OF A DECISION ON APPEAL. (ACTION ITEM)

The Council held a public hearing on appeals of Certification of Consistency Number C20242 for the 2024-2026 Proposed Geotechnical Activities, submitted to the Council by the Department of Water Resources on October 8, 2024.

The Council Clerk provided an overview of the public comment process.

Chair Lee opened the hearing and explained the hearing process.

Jeff Henderson, Deputy Executive Officer of Planning for the Delta Stewardship Council, provided a brief overview of the certification and appeal process.

Councilmembers and Council staff asked questions of the parties after each presentation.

Krystal Moreno a representative of the Shingle Springs Band of Miwok Indians commented on the impact of the proposed activities on tribal communities, including tribal consultation and ongoing challenges with the proposed activities.

Kyle Griffith with Californians for Water Security commented on the importance of the Delta Conveyance project and the geotechnical activities.

Cintia Cortez with Restore the Delta commented on the Council's responsibility to protect tribes and Environmental Justice communities through policies, and laws.

Chris Martin with the Los Angeles County Business Federation commented on the need to continue the geotechnical work for the state's water supply.

John McHale on behalf of the American Council of Engineering Companies of California commented on the importance of the geotechnical activities.

Taneicia Herring on behalf of the California- Hawaii NAACP commented in support of the geotechnical work and the Delta Conveyance Project.

Duane Martin, a rancher and resident of the Delta commented on how the geotechnical activities affect his business.

Ivan Senock commented on the need for tribal consultation and the need to use best available science and resources to consider the impacts of the Delta Conveyance Project.

Amber McDowell with the Sacramento Farm Bureau commented on the effect of the Delta Conveyance Project on farmers and Delta residents.
