The DPIIC will tour the Dutch Slough Tidal Restoration Project to see an on-the-ground example of ecosystem restoration. DPIIC members will meet at Dutch Slough to tour the site and hear from representatives from the California Department of Water Resources, U.S. Geological Survey, River Partners, U.C. Berkeley, and U.C. Davis.
