## Parking

Free parking is available in the lot at the facility. Although the address for the Bay Model Visitors Center is on Bridgeway, the building itself is located on Marinship Way, which splits off Bridgeway and runs down a small hill to the building.

The street in front of the Bay Model Visitors Center was changed in 2015 so that the parking lot can be accessed from either direction, but the only exit from the Bay Model Visitors Center is by turning south (turn left and go through the narrow parking lot upon exiting the main parking area). The route coming to the Bay Model Visitors Center is unchanged.

The street that leads to the building has very little signage, and the facility looks like an industrial building with a series of rounded roof areas until the corner by the driveway.
