Purpose

The Delta ISB will meet from March 27 to 28. On March 27, the Delta Independent Science Board (Delta ISB) will meet to discuss its activities. This will include discussing draft prospectuses for its subsidence reversal, food-webs, and decision-making under deep uncertainty reviews. Based on the discussion, the Delta ISB may take action on next steps for finalizing each prospectus, which may include circulating the prospectus to various mailing lists for public comments. In addition, the Delta ISB will discuss the election of a new Chair-elect and may take action to elect a new Chair-elect from its existing membership.

In addition, Gilbert Cosio, President of River Delta Consulting, and Tom Slater, Delta Protection Commission Member, will provide an overview of the impacts of recent storms on the Delta and how communities responded.

The Delta Science Tracker is a comprehensive web-based inventory of scientific research and monitoring activities in the Sacramento-San Joaquin Delta that builds off the inventory used for the <u>Delta ISB's monitoring enterprise review</u>.

According to the draft prospectus, this review will build an understanding of the scientific tools and concepts that can inform management and policy decision-making under rapid change and increasing uncertainty of future forecasts. Based on the discussion, the Delta ISB may take action on next steps for finalizing the prospectus, which may include circulating the prospectus for public comments.

9. <u>Discussion</u>: Subsidence Reversal Review (Action Item)

The Delta ISB will discuss its draft prospectus for its review of subsidence reversal. According to the draft prospectus, the purpose of this review is to support ongoing and future subsidence management efforts by summarizing, examining, and assessing the existing or planned programs, barriers and opportunities, state of scientific understanding, and the scientific gaps and deficiencies of interconnected areas of subsidence. Based on the discussion, the Delta ISB may take action on next steps for finalizing the prospectus, which may include circulating the prospectus for public comments.

10. <u>Discussion</u>: Food-webs Review (Action Item)

The Delta ISB will discuss its draft prospectus for its review of food-webs. According to the draft prospectus, the purpose of this review is to assess the importance of food web interactions in the Delta, and to identify where improved understanding and tools (e.g., food web models) could substantially improve predictions of species' responses to environmental drivers and management actions. Based on the discussion, the Delta ISB may take action on next steps for finalizing the prospectus, which may include circulating the prospectus for public comments.
